## Curriculum vitae

Cristina Coteanu is diplomat and deputy director at the Minister of Foreign Affairs. Without party affiliation, Cristina Coteanu was appointed as Secretary of State of the Ministry of Justice in Romania in charge of European and International Affairs. Previously, Cristina Coteanu was Director with Deloitte & Touche (Brussels) and Director with TeamEurope (European Commission's panel of experts) while being called to the Brussels Bar in 2000.

Cristina Coteanu's principal areas of work include European and international law, European and foreign policy. Prior to qualifying as a Belgian 'Avocat', she was Director of a legal department for the Central and Eastern Europe countries of the Council of the Bars and Law Societies of the European Union (Brussels). She worked for the American Bar Association in Washington D.C. and for the European Parliament in Brussels. Cristina Coteanu acquired extensive experience in running multi-country European projects involving different national systems and cultures. She has worked full-time on legal and European affairs in the area of European law for more than 13 years and has a long list of successful projects carried out for the Commission and the Council of Europe.

She is an author and editor of many books and articles related to the cyber consumers' rights, electronic payment, privacy, European immigration, insolvency, and restructuring organisations in Europe. Cristina Coteanu published dozens of articles about the European integration and legal social transition in her country of origin, Romania. She was first in her country to publish articles, a master dissertation and a survey research on Romania's integration in the European Union in 1993.

Cristina Coteanu has many years' experience of teaching European law and is currently teaching a course in this area as a part of the University of Sorbonne Master law degree programme. Since 1997, she is associated with the Institute of European Studies from the University Libre of Brussels (ULB) and worked on many academic projects, among others with the Oxford University and the Academy of European Law in Florence.

In addition to her international professional *parcours*, Cristina Coteanu has an international academic profile. She is graduated *magna cum laude* from the University Libre Brussels in European law (LLM), graduated *magna cum laude* in International Law (LLM) from the Faculty of Law (ULB), from the University Sophia Antipolis – Nice in International Relations and Diplomacy; upgraded to MPhil by the Queen Mary College – University of London; she received

a MA degree in Management, with highest distinctions, from Solvay Business School, the leading Belgian school in management.

Cristina Coteanu was member of the Advisory Board of the PIR for Europe (Public Interest Registry, Reston, US), member of the Centre of Arbitration and Mediation OMPI (WIPO) Geneva, member of the Internet Society, USA (domain names), member of the Commission on European law, Brussels Bar, member CEPANI 'Centre belge d'arbitrage et de mediation', Brussels, member of the Arbitration Association, Paris.

She is married and has one daughter. She is French/Romanian and she lives with her family in Brussels and Bucharest. She was born on October 26, 1968 in Romania.
