Propositions

- 1. The civil society does not exist.
- 2. Democracy promoters should take account of traditional civil society as a possible factor of political influence.
- 3. Promoting democracy without effective guarantees based on mutual respect for the freedom of expression by citizens of their religious, ethnic or secular identities, is a recipe for conflict.
- 4. Donor assistance for democratic governance as part of development cooperation is in the case of authoritarian regimes an ineffective and obscure strategy.
- 5. The Liberal discourse of civil society as a pro-democracy force diverts attention from structural factors in state society relations contributing to authoritarianism.
- 6. The principle of ownership in development strategies by partner countries is an effective tool for authoritarian regimes to undermine donor promotion of democratic governance.
- 7. The development of a market economy is not in itself a sufficient condition for the growth of a vibrant civil society, nor for democratization.
- 8. As long as Syrians have no consensus about the Syrian national identity, a peaceful transition to a democratic political system seems unrealistic.
- 9. An authoritarian state can allow civil society to play a constructive role in socio-economic development but not in the promotion of transparency and accountability of public bodies at all levels, because the latter would undermine its power.
- 10. Strengthening the capacity of organisations which are part of the state corporatist system will not by itself lead to an increase in the accountability and transparency of government.
- 11. Allowing civil society to play a larger role, but without providing it the means to express itself politically, is unlikely to stem the growth of opposition, including militant Islamic movements. (Moubayed, 2006: 6.)
- 12. In order to bring about democratic change, it is more effective to invest in dialogue than to invest in arms.
- 13. The more the violence grows, the more the civilian scope is 'sucked up' by extreme solutions, while it is necessary to give it breathing space again and a voice to civil society (Father Paolo Dall'Oglio, 2012: Without a page number.)
- 14. The risk with political commentators as well as with policy makers is that they observe what they want to see.
- 15. In the social reality the truth has many faces.
