## Acknowledgements

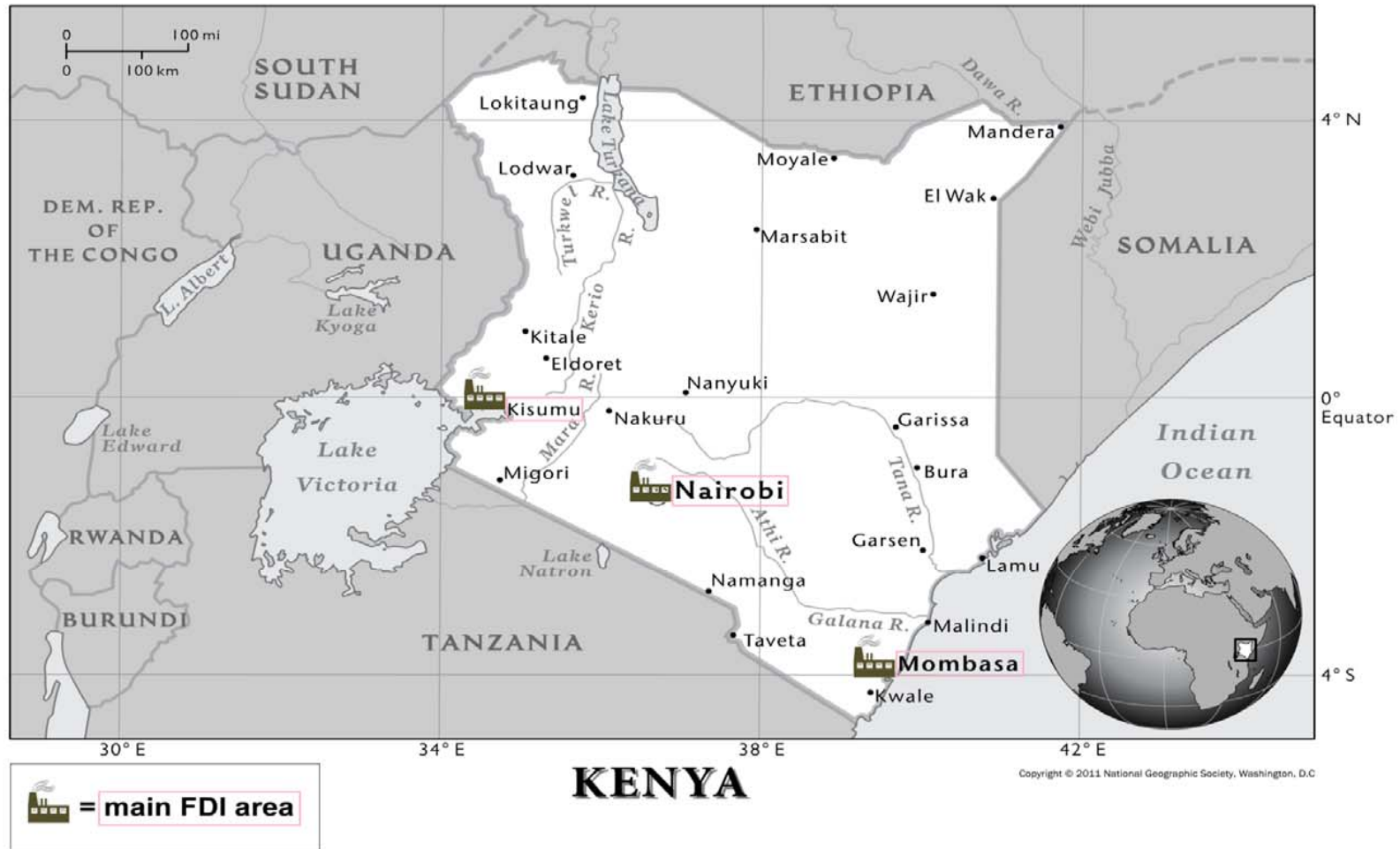
