This also gives me the opportunity to express my gratitude to Harco and Lucia for their warm hospitality during my visits to Leuven.

My work on the Siutian coffins would not have been possible without the investment made by Dr. R. Hannig. In a gesture seldomly seen, in December 1998 he granted his full video and photographic archive of Siutian coffins to the present research, without asking anything in return. This gift not only saved me a lot of work and costs. Above all, it enabled me to verify many unpublished or ill-published sources otherwise inaccessible or difficult to reach. Many of the conclusions arrived at, especially with regard to the epigraphy of the coffins, are fully due to his contribution.
