Curriculum Vitae

Asim Zubčević was born on the 29th of November, 1968, in Sarajevo, Bosnia. He attended the Gazi Husrev-beg madrasa in Sarajevo from 1983 to 1987, before serving his year of compulsory military service in the Yugoslav National Army. In 1988, he enrolled at the Faculty of Islamic Theology of the University of Sarajevo. The following year, he continued his studies at Aligarh Muslim University, from which he graduated in 1993 with a major in philosophy. In 1993, he was won Lord Mayor of Oxford's scholarship and was a visiting fellow at the Oxford Centre for Islamic Studies. Thanks to a scholarship from the Centre, he completed an M.Phil. in Medieval Arabic Thought at Worcester College, Oxford University, in 1996. He worked at the Oxford Centre for Islamic Studies from 1996 to 1998, before returning to Sarajevo at the end of 1998 to work as a freelance translator. From 2002 to 2004, he was based at the Centre for Middle Eastern and Islamic Studies of the University of Cambridge, as the Secretary of the Centre and coordinator of the Sunna Project. Since 2005, he has been Librarian at the Faculty of Islamic Studies, University of Sarajevo. In 2004, he enrolled as a part-time PhD candidate at Leiden University.
