## BIBLIOGRAPHY OF FOREIGN-LANGUAGE LITERATURE ON THE NETHERLANDS OF INTEREST FOR POLITICAL SCIENTISTS

Political scientists from abroad who would like to study aspects of Dutch politics most times have a hard job in locating the relevant publications. In order to give them some clues, in this bibliography we have collected all political science publications in a foreign language that are known to us. We do realize that there may be many more interesting studies, and we would welcome any information on this subject.

The titles we located have been brought under the general headings „Politics in the Netherlands” and „The Netherlands in international politics”. Although we are acquainted with a number of titles on related subjects (i.e. historical and economic studies) we feel that our coverage of these subjects is too incomplete to justify publication.

Only books and articles in scholarly journals have been included in the bibliography. We did not include articles in newspapers, contributions to encyclopedias or publications from governmental information services.
