## CURRICULUM VITAE

Dorina Ibi was born in Pogradec, Albania on March 11, 1991. She grew up in Pogradec, where she completed the high school at Muharrem Çollaku in 2009 (*summa cum laude*). In the same year she moved to the United States to follow her Bachelor studies in Biomedical Sciences at Lock Haven University of Pennsylvania, from which she graduated in 2013 with the Highest Academic Achievement Honor and Educational Excellence Award (*summa cum laude*). During her Bachelor years, Dorina did an internship at Dr. Jim Jefferson's lab at Penn State College of Medicine, focusing on the altered gene expression in response to diabetes. After her graduation in May 2013, Dorina started working as a research assistant in Dr. Umut Ozcan's lab at Harvard Medical School, where she had the opportunity to participate in cutting edge research on the relation to drug development for diabetes and obesity.
