Over de auteur

Rinske Baan studeerde geschiedenis aan de Universiteit van Leiden (1994-1999). Tijdens haar studie focuste zij zich voornamelijk op de Oudheid in brede zin en de Middeleeuwen. Haar afstudeerscriptie ging over de invasie in Afrika van Scipio Africanus in de laatste jaren van de Tweede Punische Oorlog. Een verblijf aan het Nederlands Instituut te Rome resulteerde in een onderzoek naar de onderlinge concurrentie binnen de Romeinse aristocratie en de rol hierin van de familie Cornelii Scipiones in het bijzonder. Verder werd in deze periode het zaadje gepland dit ooit nog eens in een proefschrift verder te kunnen uitdiepen. Na het afronden van haar studie geschiedenis heeft zij nog de propedeuse Egyptologie gevolgd. Vanaf 2008 begon het zaadje langzaam te ontkiemen. Na jaren van wetenschappelijk onderzoek volgroeide de kiem tot het proefschrift dat nu voor u ligt.
