Acknowledgements

This dissertation was written in the context of the NWO-funded project *Monarchy in Turmoil: Rulers, Courts and Politics in The Netherlands and Germany (1780-1820)*, which started in 2017. Its intellectual roots, however, go back to my undergraduate years at the Institute for History at Leiden University. Two seminars on early modern rulers and elites from a comparative perspective, taught by Jeroen Duindam, proved to be the start of a long journey that has culminated in my current dissertation. 


