She contributed to their work in aiding the protection of environmental human rights defenders, with a particular emphasis on UN processes and fracking activists in the United Kingdom.

In September 2020 Jolein joined the Grotius Centre for International Legal Studies of Leiden Law School, Leiden University as a PhD Candidate. Here, she taught working groups, gave (guest) lectures, supervised L.L.B and L.L.M theses and conducted research for her PhD. This research, entitled *Collective Human Rights as an (Onto)Logical Solution to Climate Change – Reconceptualizing, Applying and Proceduralizing an Overlooked Category of Human Rights* was carried out under the supervision of prof. Daniëlla Dam-de Jong and prof. Carsten Stahn. During this time, she was a visiting researcher at the Centre for Climate Change Law and Governance, University of Copenhagen, for which she was rewarded a grant from the Leids Universitair Fonds. Jolein presented her research in-person in Copenhagen, Leiden, London, Messina, Oslo, Rovaniemi, and Utrecht as well as online.
