Preface

In the Late Middle Ages and the Early Modern period, casks were a familiar feature in the urban landscape. They were so common and useful that they even found their way into language, with sayings featuring casks to express ideas about value, danger, and change. In Dutch, several proverbs and expressions reflect this cultural importance: *wat in het vat zit verzuurt niet, het vat valt in duigen, kijken wat er in het vat zit, uit een ander vaatje tappen, hij is zo vol als een ton, oude wijn in nieuwe vaten, een vat vol tegenstrijdigheden, and communicerende vaten*. The same applies to the English language, in which ‘casks’ and ‘barrels’ appear in proverbs and sayings: a rotten apple spoils the barrel, to scrape the bottom of the barrel, like shooting fish in a barrel, an empty barrel makes the most noise, like putting new wine into old barrels, and a barrel of laughs.

Over the last six years, I have had the opportunity to study these casks, made possible by a grant from the Dutch Research Council (NWO, Promotiebeurs voor Leraren 2019-I). It was a journey I may have underestimated at the start, but one that ultimately demanded a great deal from me. None of this would have been possible without the support of my supervisors, Roos van Oosten, Frans Theuws, and Jos Bazelmans. Frans made this project possible in the first place, and Jos ensured it could be brought to a successful conclusion. Above all, it was Roos whose enthusiasm, sharp insight, and thoughtful guidance carried me through the most demanding stretches of this journey.

I am also fortunate to have been able to conduct this research in collaboration with others, because writing a dissertation, an essentially solitary undertaking, did not always feel that way.
